#### PREFACE

Under the heading, "MABE FAMILY TREASURES - A Mystery for Museum Staff", Cynthia Dow of SPEC wrote of Mabe family records from Corner of the Beach that were donated by Judge Coderre to the Gaspé Museum. The article referred to the arrival of Peter Mabe Sr. at Corner of the Beach some two hundred years ago and to one of his descendants in particular, Captain Daniel Mabe.

As a contribution to the growing body of information on the early and important Mabe family, "GASPÉ OF YESTERDAY" adds the records below.

TREASURE The late Mrs.Margaret G.MacWhirter of New Richmond in TROVE IN her interesting book, "TREASURE TROVE IN GASPÉ AND THE GASPE BAIE DES CHALEURS", published in 1919, notes:

"...In 1797 Adjutant Mabe, an United Empire Loyalist from Rhode Island, settled at Corner of the Beach, the British Government having granted him, and each of his sons, a tract of land. The Adjutant's sword is still a treasured heirloom in the home of one of his grandsons, Capt. Dan Mabe. The sons followed the sea. One of them, Dan, built a top-sail schooner - the first built at Corner of the Beach, and carried a cargo of fish to Barbados. He was captured by a Spanish pirate who compelled all on board to "walk-the-plank". Eighteen months later a British gun-brig, in turn, captured the pirate, and the mystery surrounding the fate of the Gaspé seamen was solved.

The present Captain Dan Mabe has spent his life in the coast trade between Nova Scotia, Quebec and Montreal. He is very observant, intelligent and courteous and much interested in the early history of his native country, responding readily to the writer's request for "story". He described the old houses with their large chimneys and the huge birch back-log and the cod-oil lamps. But these have disappeared and only remain in the memories of those who still look back to the days of childhood. Captain Mabe died since this was written..."

FAMILY ORIGINS

The origins of the Mabe family take us back in time much further than the American Revolutionary War and the arrival of Peter Mabe Sr. and his family at Corner of the Beach as United Empire Loyalists. The late Dr.G. Elmore Reaman in his book, "THE TRAIL OF THE HUGUENOTS" writes as follows:

"... The Mabee family is widespread, the name appearing as Mabile, Maby, Maybee and Mubie. The Huguenot ancestor was Seigneur Pierre Mabille de Neve, born Circa 1550 in Anjou, France. He fought in the wars of religion under the noted Huguenot leader, Admiral de Coligny, and during the St. Bartholomew's Day massacre of August, 1572 he escaped to Holland where he lived and died at Noorden. He had two sons, Gaspard and John. Gaspard was one of the signers of the Leyden Petition of July 1621 which was sent to Sir Dudley Carleton, British Ambassador in Holland, asking permission to emigrate to the New World. Being in the Dutch Navy he had previously made several trips to the Americas. John Mabille came to America and settled at Schenectady while a son of Gaspard, Pierre, married and settled in New York where he died in 1665.

In fact, members of the Mabille / Mabe family had been in the American Colonies for almost 100 years prior to the American Revolution. In common with many of their fellow Huguenots they were United Empire Loyalists and suffered exile from their American homes to live under the British flag in Canada.

At the lower edge of this aerial photo the bend in the white ribbon of the highway marks the end of the flat, sea-level lands of Corner-of-the-Beach and the start of the mountain road to Percé. MABE The Corner of the Beach lands where Peter Mabe Sr.

LANDS and his family settled in Gaspesia lay on the marine plain bordered in front by the sea and towards Percé by the rugged mountains that still impress the modern traveller. The setting of Corner of the Beach was noted by the geologist and author, Dr.John Mason Clarke in these words from his book, L'ÎLE PERCÉE -

"...on over the tickle (at Barachois), along several miles of heavy sand bank, broad and stationary now, no longer overwhelmed by the tides, but the site of mills and homes. This anchored thoroughfare of sand spreads out at the farther end into the broad fields and obvious comfort of Corner-of-the-Beach, where the protection afforded by the endroit of the waters and the impending mountains has made the land more fertile, helped vastly in the "making" of fish, and the fishermen of "The Corner" have an enviable repute for the quality of their product and a reasonable pride in their open hospitality. The panorama we have had beneath our eyes all this way is most extraordinary. ... Here on the seaward face the very vitals of the (Percé) mountains are opened and ensanguined from the wound the rasp of the sea has made. The colors of these cliffs are riotous in reds and yellows and bluegreens all the way from "The Corner" to the edge of the Percé beaches...From "Corner-of-the-Beach the mountains lie across our path..."

When the Gaspé Land Commissioners held hearings in 1819, Peter Mabe Sr. appeared them to establish his claim to lots at Corner of the Beach of 495 acres. The other claimants there were Peter Mabe Jr. (175 acres) and Jeremiah Dailley (100 acres)

The following notes on a series of Mabe family notarial acts from 1815 onwards will serve to recall the activities and interests of generations of the Mabe family.

RENOUNCING-

All claims, rights, title and interest in a certain lot of land containing about seven acres in front by thirty-three acres in depth and being part of Lot No. Six and Lot No. Seven in the first range of the Township of Percé at Corner of the Beach, bounded in front by the sea and in rear, towards the West, by lands of the second range, on one side towards the North by lands of the Heirs of the late Philip Mabe and on the other side by Henry Enderby (whose wife was a Mabe) together with the house, barn and other buildings.

[The present renunciation made for divers considerations one of which is that the said John Francis Mabe lived

for many years with Peter Mabe and Ann Sutherland, his wife, took care of them in their old age and that the said property has always been considered his since the death of the said Peter Mabe and Ann Sutherland.

To his daughters Emma, wife of Henry Edward Enderby, Corner of the Beach, Mary Ann, wife of William John Jean, Coin-de-Roch, and Louisa, (spinster)living now in household with me, all money or sums of money standing in my name, wheresoever found, in Banks or elsewhere, to be equally divided among the three with all Interest accruing thereto.

To my sons Christopher and alfred all my share and interest in the schooner, "GOOD INTENT", now wintering in the Barachois River.

To my sons Daniel, Henry and Alfred Lot No. One situated at Corner of the Beach to be divided equally among them.

To my son Alfred the dwelling house wherein I now live with all furniture and contents.

To my four sons the working implements of the farm to be used with mutual consent and goodwill.

THE MAIN
PROVISIONS(ctd)

The cattle on the farm to be divided between my sons Henry, Christopher and Alfred.

The barn to be used jointly by my sons Henry and Alfred, until such time that with his brother Alfred's help, Henry shall build one for himself.

To son Christopher half of Lot No. Nine in the Township of Malbay - the other half to be equally divided between sons Daniel, Henry and Alfred.

Lot No. One situated in the Marsh in the Barachois River to be divided equally between my four sons.

I nominate and appoint my son Daniel to be the sole executor of this my lastWill and Testament
