

# DANIEL SULLIVAN SENTENCE OF DEATH

## MARCH 1866

Court of Queen's Bench sitting at New Carlisle, Bonaventure Co., Québec. Mr.Justice Winter.



## SENTENCE OF DEATH

The yellowing paper and fading ink of its handwriting shows the one hundred and thirty years age of the Court document that sentenced Daniel Sullivan to death at New Carlisle in March, 1866. The presiding Judge of the Court of Queen's Bench for the criminal trial was Mr. Justice Winter, the Sheriff of Bonaventure County at that time, Martin Sheppard, N.P. and the Clerk of the Crown, F.D. Gauvreau. Yet, despite its age, this document not only recalls but brings into sharp focus the sad fate of Daniel Sullivan.

This recall is not exclusive to "GASPE OF YESTERDAY" for in 1977 it was included in "THE HISTORY OF NEW CARLISLE" prepared by students under a Canada Youth Program. In a section devoted to "EVENTS OF THE PAST ONE HUNDRED YEARS" was "THE HANGING OF DANIEL SULLIVAN".

In the belief that this rather unique and dramatic events of Gaspesia's past is again worthy of recall, the actual text of the handwritten SENTENCE OF DEATH and the account of "THE HANGING OF DANIEL SULLIVAN" are included in "GASPE OF YESTERDAY".



### THE CASE OF DANIEL SULLIVAN

Sometime during the early months of 1866, the exact date is unknown, a fight took place aboard a ship anchored at Paspebiac. In this struggle between two sailors, one of them, a man by the name of Michael O'Brien was wounded and a few days later he was found dead. The other sailor, Daniel Sullivan, was arrested, tried in court and sentenced to hang for the murder of O'Brien.

Despite a petition asking that the case be reconsidered, the decision of the court stood and on March I6, I866 a crowd of more than 2,000 people gathered at the courthouse of New Carlisle to witness the hanging of Daniel Sullivan.

The following is taken from documents concerning the case of the accused Daniel Sullivan.

Montreal, Tuesday, 6 March 1866

Present

His Excellancy,

In Council

His Excellency laid before the Council, the Report and Evidence taken by Mr. Justice Winter in the case of Daniel Sullivan, who was tried before him at the Court of Queen's Bench (Crown Side) in the Jown of New Carlisle, the District of Gaspé, for the murder of one Michael O'Brien, and having been-convicted thereof was sentenced to Death. Such sentence to be carried out, excecution on Friday, the sixteenth day of March, 1866.

His Excellency also laid before the Council several petitions from inhabitants of the District of Gaspé, praying for the exercise of Royal clemency in favor of the above named Daniel Sullivan.

The circumstances of the case having been fully considered by His Excellency in Council, together with the Report of the Solicitor General adverse to the commutation of the said sentence.

His Excellency was pleased to order, and it is hereby ordered that the Sentence of Deathe so passed on the said convict Daniel Sullivan be allowed to take it's course.

On verdict of Wilful Murder

After the usual proclamation calling silence, and the Clerk of the Crown having, as required by law, asked the said Daniel Sullivan, whether he hath anything to say why the sentence of death should not be prounounced against him.

And the said Daniel Sullivan answering that he hath nothing to say but puts himself upon the mercy of Her Majesty the Queen, being without protection and far away from his native land.

Whereupon the Court pronounces the following judgement and sentence - The sentence of the Court which is that of the law, is that, you Daniel (or by whatever name you may be called) be taken from this place to the Common Jaol of this County wherein you have hitherto been detained and there remain until the sixteenth day of the month of March next that on the said day, you be thence taken to the place which shall be prepared for the final excecution of this sentence and that then and there you be hanged by the neck, until you are dead -

and may the Lord Almighty have mercy upon

your soul.

My name is Daniel Sullivan
