POSSESSION AND ENJOYMENT OF LANDS \*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*

In response to requests received following the publication by SPEC of general accounts of Gaspé land claims, the following article will attempt to record in more detail the claimants of 1819. Such detail as Lot numbers, acreage and code references in the official reports will, it is hoped, provide a clearer picture of the lands that our Gaspesian ancestors sought to possess and enjoy."

GASPE OF YESTERDAY proposes to continue this project in another article dealing with 1820 and subsequent claims.

## GASPE LAND CLAIMS OF 1819

### FOREWORD BY THE COMMISSIONERS

We, the Commissioners appointed in virtue of the Act passed in the 59th year of the reign of His Majesty George III, intitled AN ACT TO SECURE THE INHABITANTS OF THE INFERIOR DISTRICT OF GASPE IN THE POSSESSICH AND ENJOYMENT OF THEIR LAND, have the honour to report, that in pursuance of the Order and of the Proclamation of His Grace, the late Duke of Richmond, Governor-in-Chief of this Province, bearing date the s9th April, 1819, we did, in the month of June, 1819, proceed to the Inferior District of Gaspé, and on the 21st day of the same month, at Douglas Town, in Gaspé Pay, commenced, after previous public notice to that effect, a Session for the reception of Claims to Lands by the inhabitants of Gaspé Bay and its neighbourhood, where, at the same time, we received and recorded all such documents and evidence as were by the claimants and opposants to claims produced in support of their respective pretensions.

On the 24th July we, in like manner, commenced a session at Percé, where we received the claims of the inhabitants of Point St. Peter, Malbay, Bonaventure Island, Anse a Beaufils, Anse du Cap and Grand Rivière, as well as the documents and testimony produced in their support.

On the 15th August we commenced receiving claims at New Carlisle where many were fyled for lands at that place and its vicinity, but the period limited by Proclamation for receiving claims in that District expiring on the first of September then ensuing, we found it impracticable, in equal justice to the whole of the District, to attend to all of the places, so as to expedite business which by the Proclamation of His Grace, the Governor-in-Chief, we were directed to visit. We therefore adjourned from New Carlisle on the 22nd August and proceeded to Bonaventure, New Richmond, Carleton and Ristigouche, for the purpose of adjourning the Sessions from those places until the following year, which we accordingly did, at the same time notifying the inhabitants by public notices in
