FOREWORD

Though the generation that knew Horatio Alger as the personification of "the local boy who makes good" has given way to one tuned into the exploits of Superman and the heroics of Star Wars, both would tend to agree that the scenario of this recall, the extraordinary career of a Caspesian fisherman's son who rose to be Fremier of Québec, is utterly fanciful. That the life of that son of Gaspesia, Edmund James Flynn, would lead him from his home in the village of Fercé, through posts of ever increasing responsibility and distinction to that of Premier of Québec is surely worthy of honour in his native land. In attempting to recall his long, eventful career, GASPE OF YESTERDAY is very aware that to do it justice a biographical volume would be required. It can only be hoped that the highlights of the Edmund James Flynn's accomplishments in Law, Politics and on the Bench, presented here, will provide inducement to the reader to make a more detailed study and gain greater insight into the life and time of this distinguished Gaspesian.

FAMILY BACKGROUND

Edmund James Flynn was born at Percé in 1847, son of James and Elizabeth Tostevin Flynn. The family names of Flynn and Tostevin were well-known and of long-standing in Gaspesia. When the Gaspé Land Claims Commission held hearing in Gaspesia in 1819-20. Mrs

EDUCATION

It is evident that Idmund James Flynn was a lad of unusual promise in his native Percé from the decision of his parents. made, doubtless, at a considerable sacrifice, to send him away for secondary and college education at the renowned Jeminaire de webec. His studies there won for him admission to laval University, located then in the old walled city of Québec. He graduated from Laval's Faculty of Law.

EARLY CAREER

The landmark year of Confederation, 1867, found Edmund James

Flynn as the Secretary-Treasurer of the muncipality of Percé. From

1867 to 1869 he also held several responsible Court posts in

Gaspesia - as Assistant Registrar, Assistant Prothonotary and

Assistant Clerk of the Court of Queen's Bench. He also served as

Registrar of the Circuit Court. The experience that he gained and
the wide contacts that he made with his fellow Gaspesians would

prove to be invaluable to his future political career in the District
of Gaspé.

In 1873 he was admitted to the Québec Bar. His legal practice, based in Québec City, would be, successively, as partner in the Law firms of REMILLARD AND FLYNN; DROUIN, FLYNN AND GOSSELIN; FLYNN AND FLYNN. His practice of Law would extend over more than

MARRIAGES

In may,1875, at Notre Dame Church, Québec, Augustine Jôté, the daughter of Augustin Jôté, proprietor of the JCURNAL DE QUEBEC and his wife, Emilie Lemieux, became the bride of Edmund James Flynn. More than three decades later, after the death of his first wife, he married again with Marie Pouliot, Midow of the late Eugène Globensky. This marriage took place in Montreal in January, 1912.

CAREER

JHRONOLOGY -

The career of Edmund James Flynn was such a full and complex one in terms of his activity in a number of functions that the following attempt is made to present its highlights, chronologically, in tabular form:

- 1874..... Assistant Professor of Law, Laval University Secretary of the Faculty of Law. 1874-1880.
- 1875..... Liberal candidate for election in Gaspé. Defeated.
- 1877..... Liberal candidate for election in Gaspé. Defeated.
- 1878...... Awarded a Doctorate in Law by Laval University.

- 1892..... Won election as Member for Gaspé and Matane. Resigned his

 Matane seat in the same year.

 Was Commissioner for Crown Lands and Receiver-General in
 the Cabinets of Hon. Boucher de Boucherville and Hon. Louis
 - Olivier Taillon 1892-1896.
- 1896..... PREMIER OF QUEBEC AND COMMISSIONER FOR PUBLIC WORKS.
- 1897..... Re-elected as Member in Gaspé.
- 1899..... Named Queen's Counsel Q.C.
- 1900..... Elected as Member for Nicolet.
 - 1907..... Chosen as Bâtonnier of the Québec Bar. Served 1907-1909
 - 1908..... Federal Conservative candidate in Gaspé. Defeated.

- 1914..... Appointed as Judge of the Superior Court for the District of Beauce served 1914-1920.
- 1915..... Appointed as Dean of Law, Laval University 1915-1921.

 Named as a Governor of Laval University 1915-1927.
- 1920..... Appointed as Judge of the Court of Ming's Bench. Served in that high post for the next seven years.
- 1927..... Died at Québec on June 7th., 1927 in his 80th year.

RETROSPECTIVE

Edmund James Flynn was known to his contemporaries as a sage scholar, a judicious administrator of public affairs, a conscientious politician, and a man who ever promoted the welfare of his country and, in particular, his native District of Gaspé. He had great mental qualities and his clearsightedness was enhanced by his power of decision and action. He is remembered as a superb debater in the Legislative Assembly where he served so long and well. From the time of his maiden speech in the House, that won for him the attention and praise of the Press of the time, he was marked for greatness. Above all, he was known as a man who was prepared to stand or fall by his honest, personal convictions.

As the life and career of Edmund Edward Flynn coincided, for the most part, with the era known as Victorian, it seems fitting to conclude this recall with the following extract from IN MEMORIAN
