In pursuance of an Act passed in the Twenty-sixth year of the reign of King George the Third intituled, An Act for the further increase and encouragement of shipping and navigation, Paul Babineau and Maxime Dugas, both of the Bay Chaleur in the Province of Lower Canada, Mariners, having taken and subscribed the Oath required by this Act, and having Sworn that themselves are sole owners of the ship or vessel called MARY JOSEPH of Carleton, whereof Paul Babineau is at present Master, and that the said ship or vessel was built at the Bay Chaleur in the year One Thousand eight hundred and three and Charles Grey Stewart, Acting Surveyor, Officer for the Act of Navigation, having certified to us that the said ship or vessel is British Plantation Built, has one deck and two masts; that her length from the fore part of the main stem to the after part of the stern post aloft is fifty-one feet, herbreadth at the broadest part above the main wales is fifteen feet three inches, her depth in hold is seven feet three inches and admeasures fifty-two 30/94 Tons; that she is a square-sterned schooner, has no Gallery and no Head; and the subscribing owners having consented and agreed to the above description and admeasurement, and having caused sufficient security to be given as is required by the said Act, the said Schooner, MARY JOSEPH, has been duly registered at the Port of Quebec.
