expanded their fishery posts to Bonaventure Island, Miscou Island and distant Labrador. At New Carlisle they operated a general store. William Fauvel became the Chief Agent of this firm of LE BOUTILLIER BROTHERS.

MAYOR OF NEW CARLISLE

With the valued advice and cooperation of Councillor Valerie Gilker and Sec.-Treas.

Douglas Smollett of the New Carlisle Municipal Council, "GASPÉ OF YESTERDAY" had access to the MINUTES of the Council for the period from 1889 to 1897 when William Le B. Fauvel was the Mayor of New Carlisle. Selected items from these MINUTES appear below and it is proposed to include other items of interest in an Appendix.

MINUTES OF JANUARY 1889

"It was moved by Wm Caldwell, seconded by Ronald Billingsley, and unanimously resolved that William Le Boutillier Fauvel, Esq.,

be appointed Mayor of this Municipality in the place and stead of James Day, who, having tendered his resignation as Mayor as not residing within the limits of this municipality."

The Council of 1889 comprised, in addition to Mayor William Fauvel, William Caldwell as Pro-Mayor and as Councillors, John Thompson, Ronald Billingsley, James Hall and James Gilker.

In 1891 Hugh Christie was appointed to Council to replace Ronald Billingsley.

Fletcher Blois became a Councillor in 1896

RESOLUTION OF COUNCIL UPON THE DEATH OF MAYOR WILLIAM FAUVEL

February 8th. The hour of seven O'clock having arrived it was moved by Mr.Kempffer, seconded by Mr.Cook,
THAT having heard with the deepest regret of the unexpected demise of our Mayor, Mr.Fauvel, this day, that this meeting do now adjourn through respect of such death until Friday next, the 12th instant, at seven P.M.

THAT by the death of William LeBoutillier Fauvel, Esq., Mayor of this Municipality and Member of Parliament for the County of Bonaventure, the people of New Carlisle and the County of Bonaventure have lost a devoted Mayor and faithful representative and a model citizen.

THAT since his residence in New Carlisle Mr. Fauvel has always distinguished himself by his spirit of enterprise and his constant devotion to the public duties imposed on him by the several positions to which the confidence of his fellow citizens had called him.

THAT this Council do hereby tender to Mrs. Fauvel and the children of our late Mayor and friend the expression of their most respectful feelings of sympathy and condolence.

AND THAT a copy of this resolution be transmitted by the Secretary Treasurer to Mrs. Fauvel and the Press.

In addition to his demanding role as the Chief Agent of LE BOUTILLIER BROTHERS CO.LTD., and his duties as the Mayor of New Carlisle, William Le B. Fauvel served as President of the Bonaventure County Agricultural Society, as Chairman of the Schoolboard of Cox and as the Vice-Consul for

Portugal. As the Federal General Election of 1891 approached, the Liberal Party asked him to stand as a candidate in the room of L.J.Riopel, M.P. who was deeply involved in the Bay Chaleur Railway Company. With the support of the Hon.Honoré Mercier, Member of the Provincial Legislature and Premier of Quebec and the organization of the Curé Thiverge he won that election and took his seat as the Member for Bonaventure in the House of Commons. He was re-elected in the General Election of 1896 but his untimely death shortly after ended a promising Parliamentary career

The official notice of his succession as Member reads as follows:

This is to certify that in virtue of a Writ of Election dated the twenty fifth day of February last, issued by His Excellency the Governor-General and addressed to William Henry Clapperton, Esq., Merchant, of Maria, Province of Quebec, as Returning Officer for the Electoral District of Bonaventure in the Province of Quebec, for the Election of a Member to represent the said Electoral District in the House of Commons in the present Parliament in the room of William Le Boutillier Fauvel who hath departed this life; Jean Francois Guité, esq., of Maria, Province of Quebec, Merchant, has been duly returned as such representative as appears by the Return to the said Writ deposited of Record in my office.
